#### Location:

Droylsden is a town in Greater Manchester, 4.1 miles East of Manchester City Centre and 2.2 miles West of Ashton Under Lyme. The town has a population of 22,689 (2011Census) whilst the borough of Tameside boasts a population of 214,000. The town is on the tram network providing easy access to Manchester and surrounding suburbs.

The property forms part of the Droylsden Shopping Centre which provides 13 large retail units and linked shopping centre with parking for 280 vehicles. The property is located on the corner of Market Street immediately adjacent to Boots. Other retailers in close proximity include Greggs, Card Factory and William Hill.
