## Location:

Piccadilly Gardens is one of Manchester's main public squares and a central transport hub, with an annual passing footfall in excess of 22 million. The area benefits from a diverse offering of retail, leisure and business uses centred onto the central green space with proposed plans for improvements to the public realm.

City Tower is a landmark Manchester office building which has benefitted from substantial investment in recent years. The subject premises occupy a prominent position below City Tower fronting Mosley Street. The subject property is well positioned adjacent to Gong Cha Café. Other nearby occupiers including Marks & Spencer Food, Lidl, NUDO, Franco Manca and The Alchemist.
