The town is approximately 27 miles to the east of Chester, 30 miles south of Manchester and 15 miles north of Stoke. The A534 runs through the town which leads directly onto J17 on the M6, providing easy access to the north west or south of the country.

The subject property occupies a prominent pitch in Hightown with a return frontage onto Hope Street which leads to the rear private car park. The subject property is not listed but does fall within the Sandbach Town Centre Conservation Area.

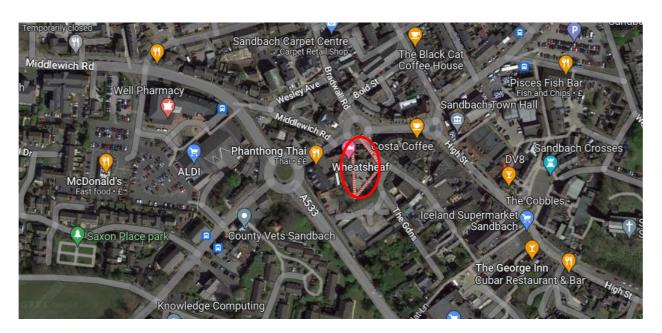
