Location:

Buxton is a historic Roman spa town situated in Derbyshire, on the edge of the Peak District National Park. The town is a popular tourist destination, attracting roughly 13.25 million people each year. The town is situated approximately 20 miles south of Manchester, 19 miles south east of Stockport and 24 miles west of Sheffield.

The subject property is located at the top of the pedestrianised Spring Gardens, which is the main shopping destination in the town, and opposite the entrance to the Spring Gardens Shopping Centre.

Laid over ground, basement and first floors, this freehold sale offers a fantastic opportunity with a wide range of uses being possible, subject to the necessary planning consents. The subject property is not listed but it does lie within the Buxton Central conservation area.




