Glossop is a an attractive, affluent market town, located to the west of the Peak District National Park, in the borough of High Peak, Derbyshire. The town is near the border with Cheshire, Greater Manchester & Yorkshire, lying approximately 14 miles to the east of Manchester city centre and 24 miles west of Sheffield.

The town has a population of approximately 32,000 persons rising to 1.17 million within 14 miles.
