- Stockport is a large, affluent town situated on the border of Greater Manchester and Cheshire. Around £1 billion is being invested in Stockport, which includes a new state-ofthe-art transport interchange, Stockport Exchange (a Grade A office and hotel scheme) and over 3,000 new homes.


