- Horwich is an affluent town on the outskirts of Bolton, and on the edge of the West Pennine Moors. The town is located approximately 21km (13 miles) north west of Manchester city centre and 6 km (4 miles) west of Bolton.
- The town boasts strong transport links with Junction 6 of the M61, 1.6 km (1 mile) away and Horwich Parkway providing regular direct trains to Manchester Piccadilly within 30 minutes.
- The town centre has an attractive mix of retailers with a few national brands and range of quality independents. The town centre is comprised of 2 main retail pitches, Lee Lane and Winter Hey Lane.


