Location & Description:

- Cleveleys is a vibrant coastal town located on the Fylde Coast in Lancashire, approximately 4
 miles north of Blackpool and 3 miles south of Fleetwood. The town benefits from excellent road
 links via the A585, which provides access to the M55 and M6 motorway networks. Cleveleys is
 well connected by public transport, with regular bus and tram services linking it to Blackpool,
 Fleetwood, and beyond.
- The town boasts a strong retail offering, centred around Victoria Road West, where a mix of
 national and independent retailers can be found. The seafront has undergone significant
 regeneration, featuring the Cleveleys Promenade and stunning coastal views. The town supports
 a resident population of approximately 12,000 and benefits from seasonal tourism, particularly
 during the summer months.
- The subject property occupies a prominent position on the corner of Victoria Road West and the A587, opposite the tram stop which provides direct access to Blackpool.


