## **Location & Description:**

- Widnes is a well-connected industrial town in Cheshire, located on the northern banks of the River Mersey, approximately 11 miles east of Liverpool and 7 miles west of Warrington. The town benefits from excellent transport links, with the A557 providing direct access to the M62, M56 and M6 motorways. Widnes railway station offers regular services to Liverpool, Manchester and Warrington.
- The town's retail is centred around Albert Road with Albert Square Shopping Centre, Green Oaks Shopping Centre and Widnes Retail Park housing many of the national occupiers.
- Widnes supports a population of approximately 61,000, with a broader catchment area including Runcorn and surrounding towns.
- The subject property occupies a prominent corner of Widnes Road with return frontage onto Travis Street and on the entrance to the pedestrianized section of the high street. The property is well configured with private rear car park, so would be suitable for a variety of different uses.
- Nearby occupiers include Cancer Research, Sunseekers, The Derby Public House and Coffee House.


