- Failsworth is a suburban town located approximately 4 miles north-east of Manchester city centre and 3 miles south-west of Oldham. It benefits from excellent transport connectivity, situated along the A62 (Oldham Road), which links Manchester to Oldham, and within close proximity to Junction 22 of the M60 orbital motorway.
- Failsworth is well served by public transport, with Failsworth Metrolink station offering regular tram services to Manchester and Rochdale. The town has a strong mix of residential, retail and light industrial uses, with key retail occupiers centred around Oldham Road and the nearby Morrisons supermarket and retail park.
- Failsworth supports a growing population and benefits from proximity to Manchester's employment hubs while retaining a distinct community identity.
- The subject property is located just off junction 22 of the M60 and is one of the first units you'd approach when travelling south down Oldham Road, into Manchester City Centre.
- Nearby occupiers include The Voujon Indian Restaurant, Emma Thomas Hair, Failsworth Travel, William Hill, Arthur Morgan Antiques and The Wheat Sheaf Inn.


