- The Supertram passes to the front of the property from Ridgeway Road to City Road.
- Nearby occupiers include Asda, Dominos, KFC and Kwik Fit.
- The property comprises a former cinema which has more recently been used as a supermarket and a discount variety store.
- The ground floor, which is accessed off City Road, comprises sales area and ancillary space. The lower ground comprises ancillary space and a rear loading bay.
- The property has the added benefit of an 18 space customer car park to the rear which is accessed off Dagnam Crescent.
