- Farnworth is a large town located approximately 2 miles south-east of Bolton and 10 miles north-west of Manchester city centre. The town benefits from strong road connections via the A666 and Junctions 3 and 4 of the M61 motorway, providing quick access to the wider Greater Manchester area. Farnworth railway station offers direct services to Bolton and Manchester Victoria.
- The retail is centred around Market Street and Brackley Street, with a mix of national and independent occupiers, as well as key amenities such as supermarkets and community services. Farnworth Leisure Centre and the nearby Moses Gate Country Park add to the town's residential appeal.
- Farnworth supports a population of approximately 26,000 and is undergoing regeneration through initiatives such as the Farnworth Green development, enhancing the retail and residential offer in the area.





