Location & Description:

- Wallasey is a coastal town on the Wirral Peninsula, located approximately 3 miles west of Liverpool, across the River Mersey. The town benefits from excellent connectivity, with the M53 motorway providing access to the M56 and the wider North West. Wallasey also has strong public transport links, with rail services from Wallasey Village and Wallasey Grove Road stations offering direct access to Liverpool city centre.
- Wallasey features a mix of retail and leisure amenities, with Liscard town centre and Cherry Tree Shopping Centre acting as the primary shopping destination. The town also boasts several attractive coastal areas, including New Brighton, a popular leisure destination with restaurants, bars, and the Marine Point retail and entertainment complex. Wallasey supports a population of approximately 85,000 and benefits from its close proximity to Liverpool.
- The property occupies a very prominent position on the corner of Wallasey Road, with return frontage onto St Albans Road. Nearby occupiers include bar Twelve Sixty, The Clairville (JD Wetherspoon), KFC, Halifax and Betfred.
