- Mansfield is the second largest urban centre in Nottinghamshire, with a
 population of approximately 100,000 and a catchment of approximately
 470,000 within a 10 mile radius. Accessed via junction 27, 28 and 29 of the MI
 and is now home to a number of large manufacturers and distribution
 companies.
- Four Seasons Shopping Centre is located in the heart of Mansfield town centre and comprises 285,000 sq.ft. of retail space across 58 retail units. As the prime retail pitch in the town, the scheme is anchored by Primark and Boots and has a strong fashion line up, which includes River Island, Quiz and Select.
- The scheme is supported by a 500 space car park, the main parking facility for the town.
- The subject property is located adjacent to River Island and WH Smith.
