Location:

Chapeltown is a large village and suburb of Sheffield in South Yorkshire. It is located approximately 7 miles north of Sheffield City centre. The retail provision in the village is centred around the railway station which is located in the heart of the village. The Asda supermarket is located to the east of the station and includes a handful of smaller external facing retail units which are occupied by local retailers as well as Your Move and William Hill.

The subject property is located to the west of the station, across the railway tracks, directly opposite the Lound Court Shopping Centre. The centre comprises of ground floor external retail units and first floor residential accommodation. Chapeltown Post Office is located in the centre.


