Location:

Coulby Newham is a busy district centre 3 miles south of Middlesbrough. It is easily accessible from the A174 and benefits from a large local catchment of 621,000 persons

within a 30 minute drive time.

The scheme provides 210,000 sqft of retail accommodation and is anchored by a large Tesco. Other key tenants include Boots, Superdrug, Poundland, Iceland, Specsavers, Greggs and Burger King. The site is also home to a council leisure centre, public library and NHS doctors and dental surgeries, effectively acting as the town centre.


