# Location:

Bootle is located within the metropolitan borough of Sefton, some three miles north of Liverpool city centre. Bootle has a total resident population of 77,640 and is one of the two main administrative headquarters for the metropolitan borough of Sefton.

The Strand Shopping Centre is Bootle's premier shopping location boasting over 100 retailers in more than 415,000 sq.ft of retail space over two levels. The scheme is anchored by TJ Hughes, Boots, B&M, Iceland, New Look and Peacocks. With an average weekly footfall of approximately 110,000 (2018), the centre attracts shoppers from within the core catchment.
