Oldham is a town in Greater Manchester, North West of England, located approximately 5 miles (8.5 km) southeast of Rochdale and 7 miles (11 km) northeast of Manchester. Oldham had an estimated population of 230,800 in 2015.

The subject property is located on Yorkshire Street, which is a secondary/tertiary retail pitch, to the east of the town's retail core.


