Location:

Leigh is a town in the Metropolitan Borough of Wigan, Greater Manchester, located approximately 12 km southeast of Wigan and 15 km west of Manchester.

The subject property is well located on King Street, one of the main thoroughfares through the town centre, which links to Bradshawgate and the Spinning Gate Shopping Centre, providing the town's main retail offering. Also located nearby are Aldi and Tesco, as well as Leigh Bus Station which is located on the opposite side of King Street.

The property is a very attractive period building comprising basement, ground, first and second floors. The ground floor benefits from great ceiling height and has a part glazed retail frontage, with stepped up access from King Street.


