## Location:

Richmond is an affluent and attractive market town situated at the gateway to the Yorkshire Dales. The town sits 35 miles north of Harrogate and 13 miles north west of Darlington. The A1 (M) is approximately 7 miles to the east. The town is a popular tourist destination with Richmond Castle and Easby Abbey attracting visitors all year round.

The main retail pitch surrounds The Green Howards Museum which is located in the heart of Market Place. The Market place offers ample parking and hosts the popular outdoor market every Saturday at the top end. National retailers present in the town include Co-op, Mountain Warehouse, Boots, WH Smith.


