Location:

Barrow in Furness is a seaport town and has a resident population of approximately 67,000. Barrow in Furness is located approximately 34 miles southwest of Kendal, 48 miles west of Lancaster and 85 miles south of Carlisle.

The property is shown for identification purposes on the attached goad plan and occupies a 100% prime retail location. The property benefits from rear servicing from Fell Street. The property is on the pedestrianised section of Dalton Road, close to its junction with Portland Walk, with the added benefit of the town's main shoppers' car parks immediately to the rear of the premises. The property comprises the ground floor of a modern 2-storey retail property (the first floor is to be converted to alternative use)
