Location:

Widnes is located approximately 14 miles south east of Liverpool and 7 miles west of Warrington. The town has a population of 60,221 (Census, 2011).

Green Oaks Shopping Centre is the only enclosed shopping centre in Widnes and is anchored by a 83,000 sq.ft. Morrisons food store. The scheme benefits from frontages on to the prime section of Albert Road and also to the Morrisons customer car park which offers 1,100 free car parking spaces. Retailers represented include Pandora,Peacocks, Select, Roman, O2, Three and TJ Hughes.


