#### Location:

Prescot is a busy Merseyside town located some 11 miles (18 km) east of Liverpool.

Eccleston Street is the main shopping thoroughfare in the town. The subject property occupies a prominent corner location with the Shakespeare North Playhouse to the rear. The rear area of the property can be used for external seating. Other nearby occupiers include Waterfields, Reeds Rains and Halifax

The property is situated within the Heritage Action Zone. Knowsley Council has allocated circa £130,000 for works to improve the structure of the building and elevations.
