## Location:

The centre also neighbours Loom Retail Park which is linked via a new pedestrian crossing. The Spinning Gate centre is the prime retailing area and the schemes hosts a number of national and local retailers including B&M, Holland and Barrett, Peacocks, Costa and Card Factory.


