## Location:

The premises occupy a prominent position on the corner of Pinstone Street and Charles Street. Pinstone Street forms a busy pedestrian link between the prime shopping of Fargate and the The Moor. Nearby traders include Superdrug, Card Factory, Skipton Building Society and Betfred.

The Moor has undergone a significant redevelopment and is home to Debenhams, the new Moor Markets, Primark, JD Sports, Gap and many more national multiples. Phase 3 is now on site with Next, H&M, River Island, New Look and Lane 7 all due to open.

Diagonally opposite the subject property is the Heart of the City II scheme including a 140,000 sq.ft office headquarters building now occupied by HSBC. International fashion brands Monki and Weekday opened on the ground floor late 2019.
