Location:

Bootle is located within the metropolitan borough of Sefton, some three miles north of Liverpool city centre. Bootle has a total resident population of 77,640 and is one of the two main administrative headquarters for the metropolitan borough of Sefton.

The Strand Shopping Centre is Bootle's premier shopping location boasting over 100 retailers in more than 415,000 sq.ft of retail space over two levels. The scheme is anchored by Marks & Spencer, Wilkinsons, Boots, B&M, Iceland, New Look, Peacocks and Tesco Metro. With an average weekly footfall of approximately 200,000, the centre attracts shoppers from within the core catchment.

We understand that the unit is assessed under the 2010 revaluation at £92,500. From 1 April 2015 the Rates Payable will be £45,602 per annum.

Interested parties should satisfy themselves as to the rateable value and business rates payable by making their own enquiries with the Rates Department at Sefton Council. The Chancellor has announced that from 1st April to 30th June 2021, eligible businesses will continue to receive 100% rates relief. From 1st July 2021 to 31st March 2022, eligible businesses will receive 66% rates relief. The business rates multiplier for 2021/22 is 49.9p for small businesses, and 51.2p for all other businesses.
